Care Coordination for African American Pregnant Individuals.

The Pathways Community HUB at the San Joaquin Community Foundation (PCH) is a demonstration project to implement the Pathways Community HUB Institute® Model (PCHI Model) http://pchi-hub.org that is directed by a Core Team of Community Leaders. This pilot is focused on individualized family support to improve birth outcomes by reducing the incidence of low birth weight (LBW), preterm babies and infant mortality in targeted high-risk areas in San Joaquin, CA. The project is currently funded by the California Health Foundation, Dignity Health, CommonSpirit Health Foundation, Abbott Fund and San Joaquin Community Foundation.

We are currently seeking applications from Community-Based Organizations that currently have community health workers (CHW) on staff or are willing to hire and supervise CHWs to be trained and deployed to provide community-based care coordination through the PCHI Model. The target population is African American maternal individuals in areas of San Joaquin County with a history of poor birth outcomes. The successful applicants will be considered Care Coordination Agencies of the San Joaquin Pathways Community Hub. Priority will be given to applicants that already have a funding source for staffing. The selected agencies will be eligible for startup funding and engagement fees and outcome payments for successfully engaging the target population and completing health and social determinants of health Pathways. To provide clarity on the role of Community Health Workers, please see the linked sample job description for a Community Health Worker and Community Health Worker Supervisor.
